A pre-bid meeting will be held at 10:00 am on July 13th 2021 at the project site, Oakwood Substation, Warren Barrett Drive and Orchard Avenue Intersection, Hannibal, MO. Attendance is encouraged for this meeting.

Bids shall be received for the aforementioned items.

A certified check or bank draft on a responsible, solvent bank, or a satisfactory bid bond executed by the bidder and an acceptable surety company, payable to the Hannibal Board of Public Works, General Manager, or Government Bonds or cash in the amount of not less than five percent (5%) of bid, shall be submitted with each bid.

The bid shall be marked to identify bid package contents, reference specification 2018 K001.

The successful bidder will be required to:

- Register as a bidder for this project with BHMGE Engineers.
- Furnish **in duplicate** the following executed documents:
 - Non-Collusion Affidavit
 - Bid Form
 - Bid Bond, Certified Check or Money Order
 - And any other documents as required by the specifications.

No bid shall be withdrawn after the opening of bids without the consent of the Board for a period of sixty (60) days after the scheduled time of closing bids.

The said Hannibal Board of Public Works reserves the right to reject any or all bids and to waive any informalities in bidding, and to determine and accept the bid most advantageous to the Board.

1. Sealed Bids for the Oakwood to Southside 34.5kV Line and Warren Barrett Drive 13.8kV Relocation project will be due August 11th. The time and location have not changed.
2. Substantial completion date as defined in the bid specifications 2018 K001 will be changed to May 1st, 2022 and final completion date as defined in the bid specifications 2018 K001 will be changed to July 1st, 2022 (originally February 1st, 2022 and April 1st, 2022 respectively).
3. Due to project proximity, Douglas Fir species poles will be allowed for 65ft and taller poles – please indicate which pole heights and classes will be substituted with Douglas Fir on the unit summary sheet for poles by writing in “DF” in appropriate row as applicable.
4. KMZ files outlining project location for lump sum price in 5.01C and for Alternate 1 and Alternate 2 for lump sum prices in 5.01D are available through bid documents link. These are to be used as location clarification tools and not for unit determination or official project scope documents.
5. “Specifications for Wireline Occupancy of Norfolk Southern Corporation Property” are available through bid documents link. Note that permit will be obtained by owner/engineer, but it is responsibility of contractor to fulfill all permit requirements, and contractor is responsible for all construction activities.
